

**Momma's Suite Seats**  
**Contest Rules**  
**Promotion Dates: 9/18/17 – 10/2/17**

**1. Eligibility**

Momma's Suite Seats - Momma Goldberg's Deli Auburn Suite Ticket Giveaway (the "Contest") is open to legal residents of the forty-eight (48) contiguous United States and the District of Columbia (excluding Florida) who are at least eighteen (18) years old at the time of entry. **5. How to Enter**

Limit one (1) entry per person, per email address, and per household on each participating social page for the duration of the Contest Period. Entries received from any person, e-mail address, or household in excess of the stated limitation will be void. In the event of a dispute as to any online entry, the authorized account holder of the email address used to enter will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holders. All entries become the property of Sponsor and will not be acknowledged or returned.

## **6. Prize Drawing**

On or about October 3, 2017, a panel of judges selected by the Sponsor will choose a winner from the best fan images submitted and tagged with @mommagoldbergs and #MommamasSuiteSeats. The odds of being selected depend on the number of entries received. The Sponsor will attempt to notify the potential winner via telephone or email on or about October 3, 2017. If the potential winner cannot be contacted within one (1) day after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place from the remaining non-winning, eligible entries.

## **7. Winner Notification**

The potential winner will be notified by email or phone. The potential Grand Prize winner (parent/legal guardian if a minor in his/her state of residence) will be required to complete, electronically sign and submit a Declaration of Compliance within two (2) days of the date notice or attempted notice is sent, in order to claim his/her prize. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to damage the website or undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law.
